When any proposal is made to establish trustee areas, rearrange the boundaries of trustee areas, or increase to seven or decrease to five the number of members of a governing board, the San Bernardino County Committee on School District Organization ("County Committee") must call and conduct at least one public hearing in the district on the matter (Education Code Section 5019).

The purpose of this hearing, pursuant to Education Code Section 35720.5, is for the County Committee to hear public comment on the proposed establishment of By-Trustee Area elections of Governing Board Members for the Etiwanda School District. The current method is At-Large elections.


